Other Fees & Disclosures:

Late Payment Fee:

\$15.00 or the amount of the required minimum payment, whichever is less, if you are one or more days late in making a payment.

Balance Transfer Fee (Finance Charge):

\$20.00 or 2.00% of the amount of each balance transfer, whichever is greater, however, the fee will never exceed \$300.00.

Cash Advance Fee (Finance Charge): \$1.00.

<u>Returned Payment Fee:</u> \$30.00 or the amount of the required minimum payment, whichever is less.

Card Replacement Fee: \$6.00.

Document Copy Fee: \$2.00.

Statement Copy Fee: \$2.00.
